- (1) NAPIS services correspond with the client's enrollment type: caregiver enrollment or care recipient enrollment.
- (2) The client must be registered for service. Registering a client for NAPIS services is entered in the NAPIS 2.0 software application for individual clients.
- (3) NAPIS requires reporting units of service in the NAPIS 2.0 software at the **client level** (defined as entering service units to individual client records) or reporting units of service in the **aggregate** (defined as entering aggregate unit counts at the service and vendor levels).
- (4) MMAP program information is reported in NAPIS **only** if the Area Agency utilizes funding under the Area Plan, i.e., Title III Part B of the Older Americans Act to supplement the contract between the Area Agency and the organization MMAP, Inc.
- (5) Cluster 5 caregiver units are entered in the aggregate for caregivers caring for *care recipients* (i.e., non-grandchildren and/or individuals aged 18 and older) or for caregivers caring for grandchildren or those under age 19.

**Regional Service Definition (RSD).** Regional Service Definitions are services directly provided by an Area Agency on Aging. Regional direct services must be approved by the Michigan Commission on Services to the Aging prior to an Area Agency providing the service.
