CONTINUING EDUCATON ACTIVITY - DOMESTIC VIOLENCE

October is Domestic Violence Awareness Month.

Family and domestic violence including child abuse, intimate partner abuse, and elder abuse is a common problem in the United States. Family and domestic violence are estimated to affect 10 million people in the United States every year. It is a national public health problem, and virtually all healthcare professionals will at some point evaluate or treat a patient who is a victim of some form of domestic or family violence.

The National Institute of Health offers this Continuing Education Activity, which describes the evaluation, reporting, and management strategies for victims of domestic abuse and stresses the role of team-based interprofessional care for these victims.

TALKING TO PARENTS ABOUT VACCINES

Many parents have questions about their children's vaccines, and answering their questions can help parents feel confident in choosing to immunize their child according to the CDC's recommended immunization schedule.

Many parents won't have questions about vaccines when you give your strong recommendation and use language that assumes parents will accept vaccines for their child. If a parent questions your recommendation, this does not necessarily mean they will not accept vaccines. They consider you their most trusted source of information when it comes to vaccines and sometimes parents simply want your answers to their questions.

Because vaccines are very effective, many parents have not seen a case of a vaccine-preventable disease firsthand. Therefore, they may wonder if vaccines are necessary and if the risks of vaccinating outweigh the benefits of protection from vaccine preventable diseases.

The Centers for Disease Control and Prevention's website "Vaccines for Your Children" is an evidence-based page for parents.

MONKEYPOX

The local health department has been provided a small number of JYNNEOS vaccines which are available to individuals who have been exposed to a confirmed case, individuals who participate in highrisk activity, individuals with multiple sex partners, individuals taking HIV PreP or living with HIV, or individuals who plan to have close contact at a high-risk venue or event.

Additionally, we have a small number of courses of Tecovirimat (TPOXX) from the CDC's SNS program. TPOXX antiviral is for the treatment of Monkeypox.

MDHHS has provided these antivirals to the local health department for prescribing by local Providers. Should a Provider need to prescribe, please reach out to any of the following RN/Clinic Supervisors that make up our Communicable Disease team:

MICHEM MONITORING COMING TO BRANCH AND HILLSDALE COUNTIES

The MiChEM project is the first statewide effort to gather data on the concentrations of certain chemicals in the blood and urine of Michiganders, including lead, mercury, and per- and polyfluoroalkyl substances (PFAS).

MDHHS has randomly selected 66 areas of Michigan to include in the MiChEM project. This includes a geographical area in Coldwater, and Adams, Wheatland, Pittsford and much of Jefferson townships in eastern Hillsdale County. MDHHS will invite residents from approximately 2,000 randomly selected households in each area to participate.

Participants will answer survey questions online or by phone, which will take about 20 minutes. These questions are about how they may have come in contact with certain chemicals.

Participants will attend a 30-minute appointment, during which a trained professional will collect a blood sample and ask for a urine sample. The testing will be looking for 17 organochlorine pesticides, 45 per- and polyfluoroalkyl substances (PFAS), 1 polybrominated biphenyl congener (PBB), 10 polybrominated diphenyl ethers (PBDEs), 100 polychlorinated biphenyls (PCBs), and 24 metals including; Lead, Mercury, Arsenic, Aluminum, Manganese, Chromium, Selenium, Thallium, Cadmium, and Cobalt.

Participants will receive the results of their testing and a \$65 gift card.

COVID-19 Update

The Branch Hillsdale St. Joseph Community Health Agency continues to monitor and update the latest regional and county data at www.bhsj.org/coronavirus.

At the time of this writing, the CDC reports the community transmission rate as "Low" in in all three counties. This trending pattern of small surges is expected to continue as residents transition into fall and gather for holidays.

Case counts are impacted by unreported "at home tests". Cases of hospital admissions remains low at the time of this writing.

The agency now offers bivalent COVID-19 booster doses to anyone over age 12 who have not received a dose of vaccine in at least 2 months. In addition, we offer Novavax as an option for those not wishing to receive an mRNA vaccine.

INFLUENZA VACCINES

I encourage providers to talk with their patients about receiving their flu shot as soon as possible. Flu shots are readily available within PCP offices, local pharmacies, and at our offices. While influenza cases have been low during the past 2 years, influenza has not gone away.

With the St. Joseph and Hillsdale County fairs at the end of September, be mindful to look for Swine Flu in patients presenting with influenza symptoms with a history of spending long periods of time in swine barns.

WIC NATIONAL ENROLLMENT WEEK: OCTOBER 10-14

The Branch Hillsdale St. Joseph Community Health Agency manages the WIC program for all three counties. We encourage all eligible families to take part in the program. It is worth noting that a pregnant patient would be counted as 2 individuals, or more if there are confirmed multiple fetuses, for the purpose of income eligibility.

If you are caring for families who are pregnant, nursing, post-partum in the past 6 months, or have children aged 5 or under, please refer to the Health Agency office near you.
